


Description

The TSL267 is a high-sensitivity low-noise infrared light-to-voltage converter that combines a photodiode and a transimpedance amplifier on a single monolithic CMOS integrated circuit. Output voltage is directly proportional to IR light intensity (irradiance) on the photodiode. The TSL267 has a transimpedance gain of 320 M Ω . The device has improved offset voltage stability and low power consumption and is supplied in a 3-lead visible-light-blocking plastic sidelooker package with an integral lens.




Figure 1. Switching Times




The device is supplied in a visible light-blocking plastic three-lead through-hole sidelooker package (S).


PLASTIC SINGLE-IN-LINE SIDE-LOOKER PACKAGE




