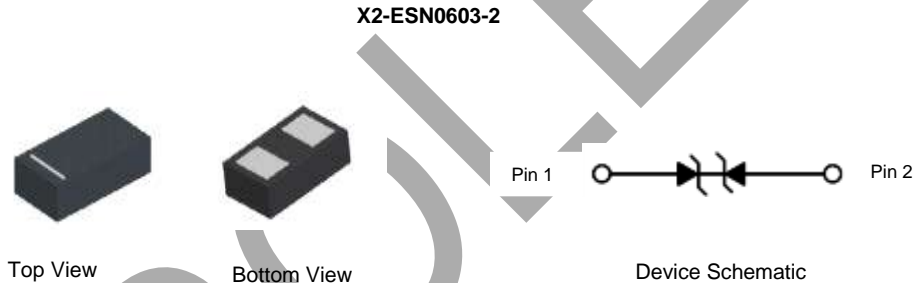

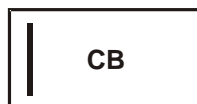

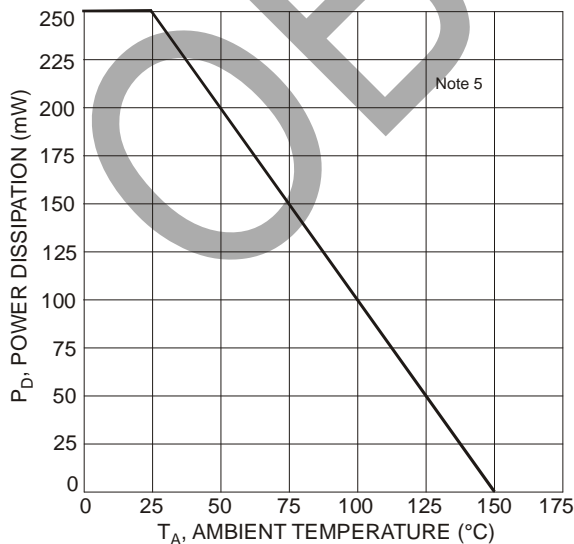


Figure 1 Power Derating Curve

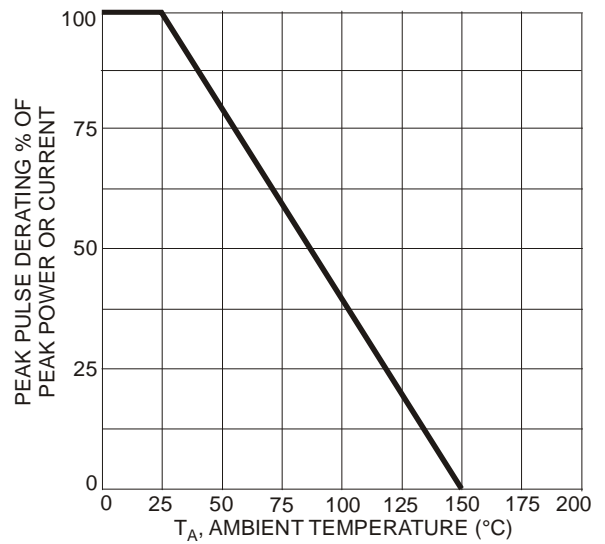


Figure 2 Pulse Derating Curve

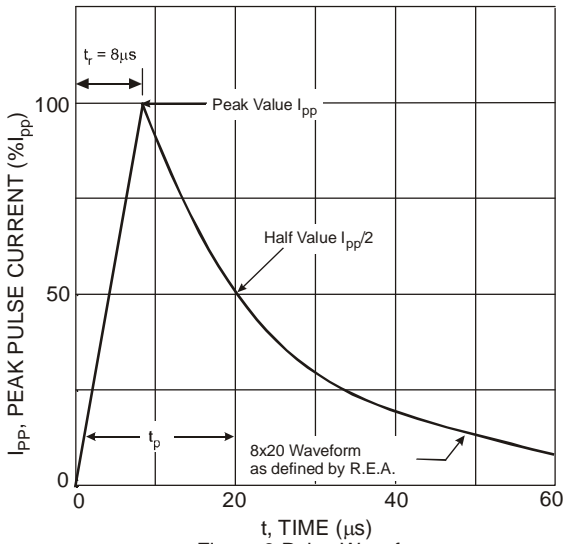


Figure 3 Pulse Waveform

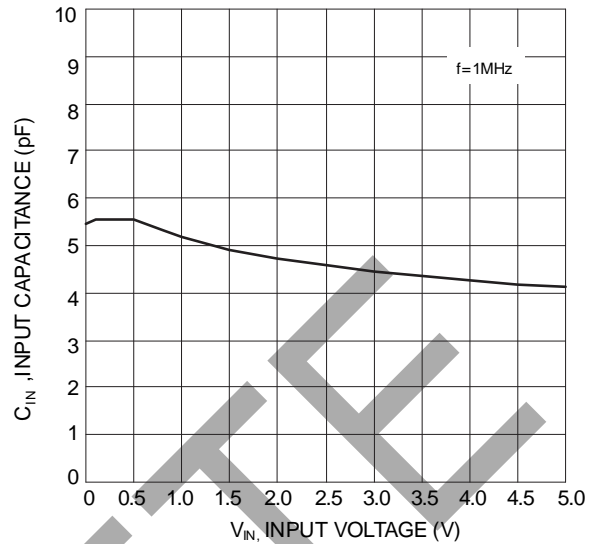


Figure 4. Input Capacitance vs. Input Voltage

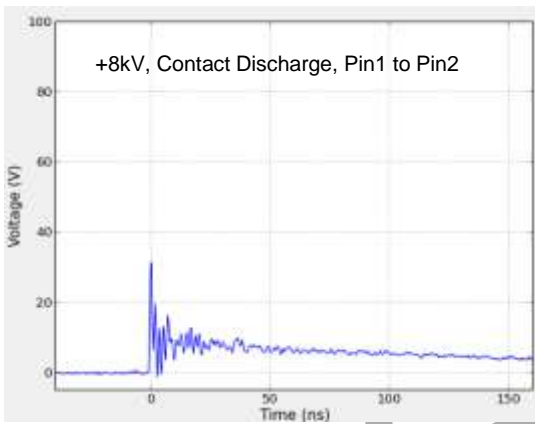


Figure 5. ESD response ESD response to IEC 61000-4-2

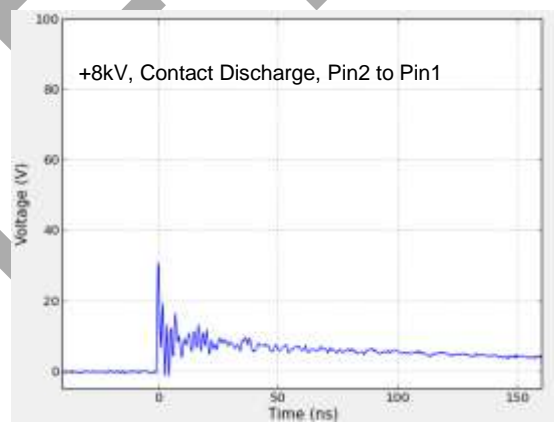


Figure 6. ESD response ESD response to IEC 61000-4-2

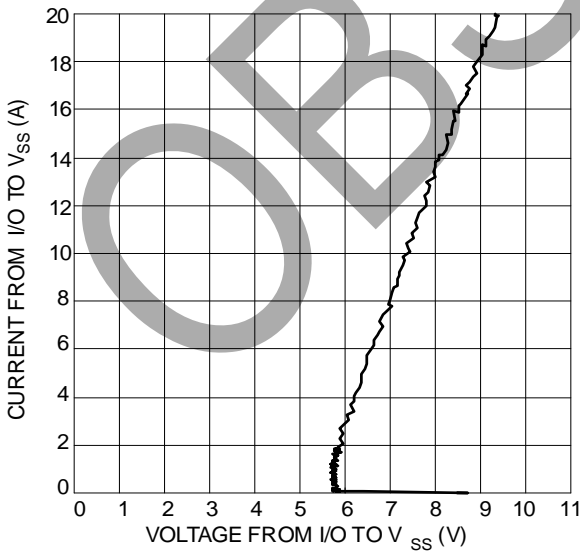
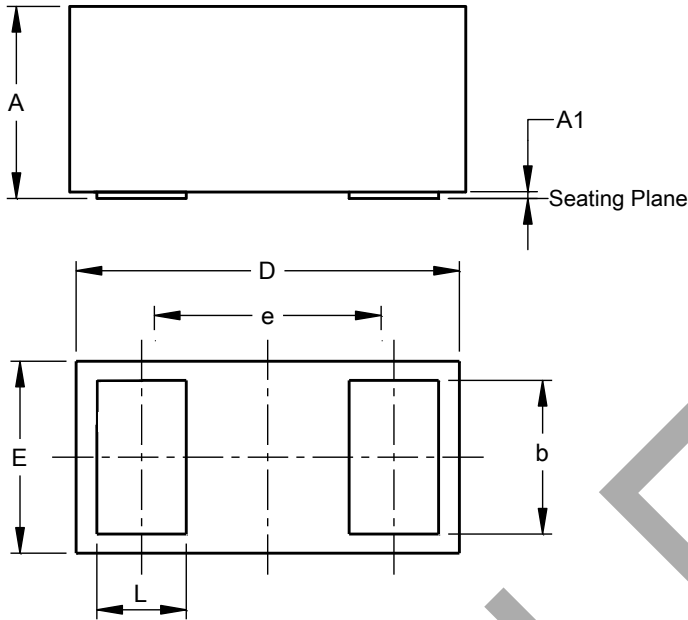


Figure 7. Current vs. Voltage

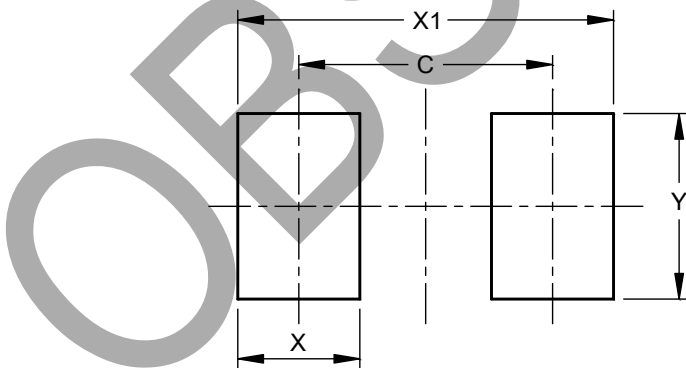
